

COST OF PROGRAM:

This program is a Direct Assessment, which is offered using a nonstandard term academic year comprised of four 12week terms. Students can choose how many courses, and associated CUs (typically 3 CUs per course), they complete each term. Tuition for University of Phoenix Direct Assessment programs is charged at a fixed amount per enrolled term regardless of the number of courses/CUs in which students are enrolled for that term. Therefore, while the amount charged per term is fixed, the total estimated tuition charges for this entire program depend on the pace at which courses/CUs are
