Summary

	a. As part of the scholarship application, the University of Phoenix will review the applicant's official University of Phoenix student account and transcripts to verify the following requirements: i. Applicant has completed a minimum of 24 credits at the University of Phoenix and has at least 18 credits remaining in their University of Phoenix bachelor's degree program as of the Scholarship application deadline. ii.
