

Forever a Phoenix® Master's Scholarship March 2024

Section	Description
Summary	<p>All new University of Phoenix bachelor's degree alumni students who (i) apply for and enroll in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.25 or higher (on a 4.0 scale) in their University of Phoenix associate's degree; and (iii) apply for this Forever a Phoenix® Master's Scholarship – March 2024 ("Scholarship") prior to the deadline and register and post attendance in their first class between March 1st, 2024 and March 31st, 2024 ("Initial Attendance Window") will have the opportunity to be considered for one of two hundred (200) scholarships worth up to a maximum of \$2,000 each, distributed over 11 courses.</p> <p>NOTE: Students must begin the admissions application prior to completing this scholarship application.</p>
Application Deadline	<p>The Scholarship application will be made available online on February 1st, 2024. Applications must be completed and submitted online at www.phoenix.edu by 11:59pm MST March 31st, 2024 ("Application Deadline"). Applications submitted after the Application Deadline will not be considered. No exceptions.</p>
Eligibility Criteria	<ol style="list-style-type: none"> 1. Applicants currently residing in the United States must meet one of the following requirements: be a legal resident of the United States; have been granted permanent residency; have a valid visa that does not prohibit educational studies; have been granted temporary protected status along with approved Notice of Action issued by Citizen Immigration Services and verified through CIS Form g-845; or have been granted asylum along with the approved Notice of Action issued by the Citizen Immigration Services. 2. Applicant must meet all admissions requirements of University of Phoenix if selected as a scholarship recipient. 3. Applicant must not be an employee (including full- and part-time faculty) or a family member (spouse, dependent child, or domestic partner) of an employee of University of Phoenix or any other affiliate of University of Phoenix, Inc. 4. Applicant must apply and be admitted to a University of Phoenix master's degree program. 5. Applicant must submit a complete, signed application, together with all supporting documentation by the Application Deadline. The completion of the application form does not create an obligation to award a scholarship to the applicant.

<p>Maintenance Requirements</p>	<p>In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:</p> <ol style="list-style-type: none"> 1. Applicant must remain in a master's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their master's program, specific to the original program level award. 2. Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship. 3. Applicant may not have an unapproved attendance gap greater than 35 days.
<p>Terms and Conditions</p>	<p>By applying for a University of Phoenix scholarship and/or accepting the scholarship award, the applicant and/or recipient agrees to the following terms and conditions. Failure to abide by any of the following terms and conditions shall result in either disqualification of the scholarship award or termination of the scholarship award.</p> <ol style="list-style-type: none"> 1. All application submissions shall become the property of University of Phoenix, Inc. regardless of applicant being awarded the scholarship. In addition, applicant agrees to execute a University of Phoenix, Inc. 2. Scholarship award is a non-cash award to recipient's University of Phoenix account as outlined on the scholarship application. Scholarship will be applied to the first credit-bearing class with a start date after the award date. No scholarship funds will be applied to previous classes or currently enrolled classes at the time of scholarship award. No check or other cash monies will be disbursed at any time. No exceptions.

The University of Phoenix treats this tuition scholarship, in the form of a non-cash award, as non-taxable income. However, the recipient is encouraged to seek independent counsel from a certified tax consultant as recipient is responsible for all other costs, liabilities, and obligations including any applicable taxes from the award of this scholarship as Federal laws may change and laws vary from state to state. The University of Phoenix makes no representations with respect to the taxability of this award and the University of Phoenix may change its treatment of the scholarship for tax purposes in its sole discretion.

3. This Scholarship may not be combined with any other University of Phoenix scholarship, offers, promotions, memorandums of understanding or other tuition scholarship(s) except for the Alumni Tuition Benefit.

Recipients remain responsible for repayment of all Federal Direct Loans borrowed for your program or any other program you have enrolled in and/or attended are subject to the repayment terms and conditions set forth in the Master Promissory Note (MPN) executed with the U.S. Department of Education.
5. This Scholarship is not applicable and will not be issued to:
 - a. Applicants who enroll in a University of Phoenix degree level or program other than what is specifically outlined in the Application's Eligibility Criteria for the scholarship.
 - b. Applicants pursuing stand-alone University of Phoenix courses.
 - c. Applicants pursuing stand-alone University of Phoenix certificates.
 - d. Applicants pursuing a Competency Based Education program.
 - e. Current University of Phoenix students
 - f. Applicants receiving any employer benefits or discounts
 - g. Applicants receiving Military Tuition Rate
 - h. Applicants who do not meet the University of Phoenix eligibility requirements
 - i. Students who enroll and start their first course outside the scholarship window.

If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations. In addition, the recipient must maintain continuous attendance as defined by the University of Phoenix and/or must qualify for a leave of absence to maintain his/her financial aid status.
