Applicants who enroll in a University of Phoenix degree level or program other than what is specifically outlined in the Application's Eligibility Criteria for the scholarship. b. Applicants pursuing stand-alone University of Phoenix courses. c. Applicants pursuing stand-alone University of Phoenix certificates. d. Applicants pursuing a Competency Based Education program. e. Current University of Phoenix Students. f. University of Phoenix Alumni. g. Applicants receiving any employer benefits or discounts. h. Applicants receiving Military Tuition Rate. i. Applicants who do not meet the University of Phoenix eligibility requirements. j. Students who enroll and start their first course outside the scholarship window. k.
