Maintenance  
Requirements

In order to continue disbursement of the scholarship award, applicant must meet the following maintenance requirements:

1. Applicant must remain in a bachelor's program (all coursework attended must be program applicable courses). Awards will only be applied to courses taken as part of their bachelor's program, specific to the original

2. Scholarship award is a non-cash award to recipient's University of Phoenix account as outlined on the scholarship application. Recipient is out of attendance on an unapproved leave of absence for more than 35 days.</li><li>d. Recipient completes their bachelor's degree program.</li><li>e. Receives the maximum scholarship award</li><li>f. 730 days from a recipient's first course.</li></ul></li> <li>7. If recipient has applied for or is receiving Title IV financial aid funding, this scholarship may reduce the recipient's eligibility for Title IV financial aid funding to comply with Title IV regulations.
